Subject : Limited Departmental Competitive Examination (LDCE) for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on 09/07/2017 - Notification of Exam reg.

Closing date of Registration : 24/06/2017 (to be done at SSA/Circle)

With the approval of the Competent Authority, it has been decided to hold a Limited Departmental Competitive Examination (LDCE) for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on **09/07/2017** as per the provision in the Recruitment Rule/scheme of **Telecom Technician (Erstwhile Telecom Mechanic)** circulated vide BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19th Sep 2012 (**Annexure-A**) in order to fill up the vacancies for the vacancy years (e.g. 2014-2015, 2015-2016 etc.)

2. The current vacancy position in the Circle is as follows :-

3. The examination will be conducted through offline written mode and as per revised Scheme and syllabus of examination circulated vide No. 250-74/2001-PERS-III(Part) dated 18th Oct 2011 BSNL CO. (**Annexure-B**). The details of Papers and Time Table of the examination will be as under :-

4. Minimum qualifying marks prescribed is 30% in each part and 37% in aggregate in respect of 'OC/OBC' candidates and 20% in each part and 30% in aggregate in respect of 'SC/ST' candidates.

5. The eligibility for appearing in the above mentioned Limited Departmental Competitive Examination shall be as per existing Recruitment Rules issued by BSNL Corporate Office Letter No. 250-74/2001-PERS-III dated 20.02.2002 (**Annexure-A**). However, in case of any doubt with regard to eligibility, Syllabus and the Scheme of the examination, the Circles may take up the matter suitably with the Estt./Pers Section of the BSNL CO. for necessary clarification.

6. The LDCE will be held in 25 BSNL Territorial Circles at their respective headquarters. The details of the Territorial Circles where the LDCE will be conducted are given at **Annexure-C**.

7. The employees, who are eligible in accordance with the eligible conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit application offline to the **Controlling authority under whom their service book is maintained at SSA/Circle level and the same would be verified as per the updated data in ERP.**

Applications will be considered only in the stipulated period mentioned above i.e. from **01/06/2017** to **30/06/2017 (to be done at SSA/Circle)**. Candidates will have to provide valid details as per **Annexure-D**.

9. The prescribed examination fee **₹750/- (Rupees Seven Hundred Fifty only)** for the **OC/OBC candidates** and **₹ 500/- (Rupees Five Hundred only)** for the **SC/ST candidates** shall be paid through **DD in favour of concerned AO Cash of the SSA/CIRCLE** only.

10. **The amount of the fee shall not be accepted in any other form. Fee once paid shall NOT be refunded under any circumstances nor can be held in reserve for any other examination or selection. Hence, the candidates are requested to ensure their eligibility for the said LDCE before applying for the same.**

11. Registration forms complete in every respect must be submitted on or before 30-06-2017. Candidates are advised to complete their registration process well before last date to avoid any delay. Registration process will not be allowed after last date and all incomplete registrations will be treated as rejected. The controlling Authority of the Candidates will issue the Hall Tickets to all between 03-06-2017 to 05-06-2017 after verifying the eligibility of candidates. BSNL shall not be responsible for any problems or delays occurring on last day of registration.

12. The applicants would be admitted to the examination on the basis of the information furnished by them in their registration form. They are, therefore, advised to ensure that they fulfil all eligibility conditions before applying. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfil any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies in the LICE and no correspondence in this regard would be entertained. Issuance of a Hall Ticket for the examination will NOT confer any right for promotion or otherwise. Promotion will be solely provisional subject to the fulfilment of all eligibility conditions.

13. No electronic gadget or mobile phone etc. will be permitted to be taken inside the examination premises by the candidates.
