

With reference to the above subject, I am hereby directed to intimate that the Circle High Power Committee met on 19-10-2016 and 25-03-2017 for examining all the applications for Compassionate Ground Appointment received upto 31-03-2016 against the vacancies of financial year 2015-2016 in accordance with new policy guidelines issued by the BSNL CO New Delhi vide Ir.no.273-18/2013/CGA/E-IV dt.01-10-2014.

After detailed examination and with reference to overall assessment of the financial condition of the family of the deceased official viz., assets/liabilities(including benefits received under various welfare schemes etc, if any), and all the other relevant factors such as presence of an earning member, size of the family, ages of the children and essential needs of the family etc., the committee did not consider the families to be living in penury and hence recommended for REJECTION of the requests pertaining to the cases mentioned in the enclosed Annexure under the provisions of the scheme for the purpose.(In accordance with instructions contained in Department of Personnel & Training laid down in O.M. no.14014/6/94-Estt(D) dated 09-20-1998.).
