31.05.2017 may be prepared by all the Circle and sent to Corporate Office by 15.06.2017.

No case will be entertained or taken up with DOT for PO without cogent reasons
for undue delay after the above given date.

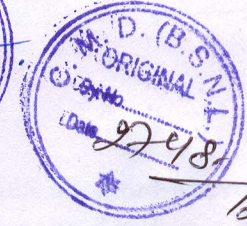
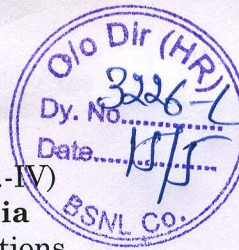

Subject: - Issue of Presidential orders to the casual Labourers, who have been conferred Temporary Status on or before 30.09.2000 and regularized in BSNL on or after 01.10.2000.

Sir,

I am directed to refer to your office letter No. 269-2/2011-P-IV/LE(Vol.-IV) dated 26/04/2017 on the subject cited above and to say that vide DoT's letter dated 20/10/2006, it was decided to issue Presidential Orders for those casual workers who were having TSM status as on 30/09/2000 and regularized in pursuance of DoT's letter dated 29/09/2000 with the approval of DoT and the BSNL was requested to take necessary action for expediting the cases. Approval for issuing of POs have been issued by this Department in thousands of cases from time to time. However, the cases for issuance of Presidential order are still being received in this office without any cogent reasons for undue delay in taking of the matter (i.e. lapse of 11 years).

2. Accordingly, the afore-said observations made by this Department may be examined and the para-wise information may be furnished to this office on following points.

- Cogent reasons for undue delay in sending the cases for Presidential order.
- Number of left out cases in M.P. Telecom Circle. Complete list of the left out cases and reasons for delay may be furnished.
- Number of similar cases in other Telecom Circles which are still pending and reasons for pendency of such cases.
- The action taken by the BSNL to ascertain the authenticity of the above mentioned cases.
- As to whether, any list (Circle wise) has been prepared by the BSNL Corporate Office which is used to examine the afore-said cases.
- In case, there is no master list prepared by BSNL, the steps taken by BSNL to examine the authenticity of the documents, records etc. relating to grant of TSM status and regularization of employees.
