
Subject: GSM Pre-paid Mobile Plan for the Non-Executives in lieu of Rs. 200/- recharging GSM SIM per month.

Ref: 1) 2-22/2002-PHA(Pt) dt.09.03.2016 (Circular No.01/2016-PHA)
2) 2-22/2002-PHA(Pt) dt.02.02.2017 (Circular No.01/2017-PHA)

The competent authority has decided to provide exclusive plan for Non-Executive employees of BSNL in lieu of Rs.200/- SIM per month. Accordingly, Tariff & Costing-CM section, has issued circular vide no. 26-07/2018-T&C-CM dated 05/06/2018.

In view of above, following instructions are hereby issued to the field units for implementation of the GSM Prepaid Mobile plan.

- 1) This facility is extended to all in-service Non-Executives of BSNL and existing Rs.200/- recharging GSM SIM per month will be extended with facilities like unlimited free voice calls (In home LSA as well as roaming area including MTNL area), 1GB Data/day, free 100 SMS /per day, in place of on-net/off-net calling facilities currently.
- 2) On quarterly basis, the Circles will issue an updated list of Non-Executives, for the concerned Nodal centers for updating of details/database including date of superannuation.
- 3) The mobile services of superannuating Non-Executives will get terminated on date of superannuation. However, they may be allowed to retain the indicator number in their private capacity.
- 4) These instruction will come into force with effect from 1st July 2018.
- 5) Other terms and conditions of the earlier circulars will remain unchanged.
