- 2. GM (SR) welcomed Chairman & all the participants from management & staff side members present in the meeting. Thereafter discussions on the new pay scales for non-executives started. The committee discussed different aspect like stagnation, pay anomaly in pay of new recruit and existing employee which were considered while framing the new pay scales. Management side suggested that maximum of new scales should not unnecessarily stretched high as the same if approved will result in increase in the burden of pension contribution on the company but at the same time it should not be so low that it may causes stagnation. The staff side members submitted some cases of stagnations in the pre-revised pay scales and the committee discussed theses case in detail.

- Staff side members suggested that some of their members may be given informal 3. meetings with the Sub-Committee of the Joint Committee to discuss the issues related to minimum and maximum of revised pay scales so that their genuine concerns are taken into consideration by the management. They requested that their first meeting with the Subcommittee may be arranged on at 30.08.2018
- The committee observed that some of the staff members may meet the Sub-Committee of the Joint committee and share their genuine concerns, so that the number of issues requiring further discussions are minimized. . The next meeting was decided to be held on 10th September 2018 at 15.00 Hrs in the Meeting Room, 8th Floor, Bharat Sanchar Bhawan.
