Please refer to this office letter cited at reference (2) (copy enclosed for ready reference) wherein it was clarified under serial No. 2, that the officials who passed their Graduation without obtaining 10+2 qualification are **eligible** to appear in the LDCE for TTA under 40% quota **should be withdrawn with immediate effect.**

Further as per the instructions issued vide CO- ND letter Lr. No. 250-3/2015-Estt.-III dated 18-05-2015 (copy enclosed), providing that " the candidates possessing higher qualifications directly without 10th and 10+2 standard are **not eligible** to appear in the LICE for TTA will holds good for future examinations." and as per the CO-ND letter cited at Ref (1), the same will holds good for future examinations.



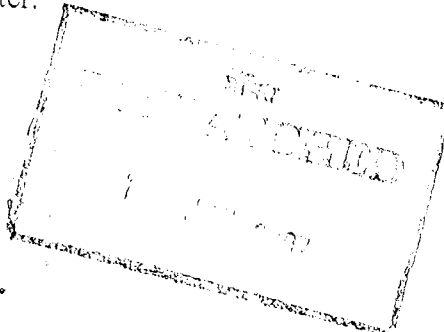

2.	Whether the Officials who passed their graduation with out obtaining 10+2 qualification are eligible to write the TTA 40% LDCE.	Yes
3.	Whether Officials who had 10 th class and 2 years ITI certificate course are eligible to write the Exam.	Please refer this Office Lr.No. TA/RE/22-10/2001, dtd. 6/2/02, item 5.
4.	The Officials belong to TOA(G) cadre who have been converted from LDC(TA) cadre are eligible or not.	Please refer this Office Lr.No. TA/RE/12-10/05, dtd. 29/6/05, para 2.
5.	Officials holding OTBP cadre & drawing the lower pay scale i.e. 6550-9325 are eligible or not.	Please refer this Office Lr.Nos. (i) TA/RE/22-11/04, dtd. 12/7/04, para I(3) -- (ii)TA/RE/22-10/05, dtd. 5/9/05.



Sub: LICE for TTA under 50% quota for the RY-2014---Clarification regarding.

I am directed to refer to your office letter No. TA/RE/22-10/TTA RY-2014/36 dated 24.04.2015 on the above mentioned subject and to clarify that as intimated by A.P. Circle, Intermediate course of NIOS and APOSS are recognized as equivalent to the Intermediate course offered in the formal system by the Board of Intermediate Education, A.P., Hyderabad, as such, candidates possessing such qualification are eligible to appear in the LICE for TTA. However, veracity of equivalent qualification is to be ascertained in writing by the Circle in consultation with concerned Stated Board of Examination/Ministry of HRD/Education Department of State Govt. or Union Govt., whichever is applicable in the case before allowing it.

As regards candidates possessing higher qualifications viz. Post Graduate/Graduate Degree/Diploma obtained directly without 10th and 10+2 standard from Open universities, the same are not eligible to appear in the LICE for TTA.
