The Limited Internal Competitive Examination (LICE) for promotion to the grade of TTA under 50% quota for RY-2014 held on 07-06-2015 was conducted by the combined AP Circle and the Results were declared by this Circle.

As per the Interim Order of Hon'ble High court of HD, in the WP Nos. 18958, 19232, 23127, 23135, 23217 & 25300 of 2016 in the matter of Md. Ghouse and others, the result of applicants who have appeared the LICE for Promotion to the cadre of TTA under 50% Quota for the RY-2014 held on 07-06-2015 was declared vide this office letter cited at Ref (2) duly mentioned that the training, posting and appointment of the applicants will be subject to the out come of the Court case.

As per the out come of the Hon'ble High Court, Hyd, BSNL Corporate Office, New Delhi has conveyed the approval vide reference cited at (1) above, for implementing the Common order dated 08-06-2018 of the Hon'ble High Court, Hyderabad in the aforesaid WPs in respect of **Petitioners only, as a special case.**

Accordingly, the following process may be initiated in respect of the Petitioners **Qualified** in LICE as mentioned in the Annexure (enclosed) vide this office letter at Ref (2).

(a) Verification of the Graduation Degrees acquired by the Petitioners may got be done by the respective SSAs/ Units from the respective Universities and their recognition may also be confirmed from concerned Regulatory body i.e. UGC etc. and if delay is expected then in order to avoid contempt of Hon'ble Court, the petitioners may be provisionally promoted as JEs after imparting requisite training which will be subject to verification of their degree certificate.

(b) Verification of Service particulars and eligibility with Service Book particulars of the Petitioners to be done by the SSAs / Units.


