The undersigned is directed to refer to the subject mentioned above which involves an important aspects of the service benefits of a sizeable section of workers who were made TSM in DOT regime on or before 30.09.2000 and without getting the benefit of absorption, were selected for the post of Telephone Mechanic through exam in BSNL regime.

The requirement of data in this regard has already been referred to all Circles vide this office letter of even no. dated 28.01.2015 & 12.06.2015 . It is very serious matter that many of the Circles viz A&N, AP, Bihar, Gujarat, Jharkhand, J&K, Maharashtra, West Bengal, ALTTC, BRBRAITT, BBNW, IT PC, NATFM, NCNGN, NETF, ETR, NFS, NTP, INSPECTION, TelecomStore, Telangana, TelecomFactories [Kolkatta, Mumbai, Jabalpur] have not furnished the required data and Karnataka, NE-II, NTR, Punjab, UP(East), Uttarakhand, ETP have supplied partial information (without certificates).

Accordingly, it is once again requested to furnish the desired data in the following format duly certified by GM(HR & Admn.) & IFA of the Circle to this office positively by **30th November 2018** in both hard and soft copy (in MS Excel) of the data. (e-mail: **id-labouresttbsnlco@gmail.com**).
