With reference to the above subject, I am hereby directed to intimate that the Circle High Power Committee met on 09-10-2018 for examining all the applications for Compassionate Ground Appointment received upto 31.03.2018 against the vacancies of financial year 2017-2018 in accordance with the new policy guidelines issued by BSNL CO New Delhi vide lr.no.273-18/2013/CGA/P-IV dt.01.10.2014.

After detailed examination basing on the latest welfare reports received from SSAs and with reference to over all assessment of the financial condition of the family of the deceased official, viz., assets/liabilities(including benefits received under various welfare schemes etc, if any), and all the other relevant factors such as presence of an earning member, size of the family ages of the children and essential needs of the family etc, the committee did not consider the families to be living in penury and hence recommended for **REJECTION** of the request pertaining to the cases mentioned in the enclosed Annexure under the provisions of the scheme for the purpose.(In accordance with the instructions contained in Department of Personnel & Training laid down in O.M. no.1404/6/94-Estt(D) dt.09.10.1998.


