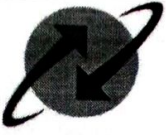

No request shall be entertained under any circumstances, if the same is received after date.
5. All formalities relating to seniority/promotion/posting & arrangements to send them for training are to be completed by the Circle concerned as per existing rule and the final feedback on the same may be forwarded to Recruitment Branch, BSNL Corporate Office.
  - I. **It is once again worthwhile to mention that the eligibility status of the candidates have been considered on the basis E-verified data of the candidate (by concerned circle) on SAP.**
  - II. **All such successful/eligible candidates must submit an undertaking, without any prejudice, to this effect for any future course of action and the Competent Authority of the Circle shall ensure to obtain the same for Service Book/ERP, accordingly.**



6. Result of Punjab Telecom circle has been kept on hold till disposal of the pending issues related to earlier LICEs.
