

A meeting was called by the TS Circle administration to discuss the matter on implementation of transfers in the cadre of Group 'C' and 'D' for Rural / unmanned stations with the Union Representatives. The meeting was held on 16-03-2019 at 11.00 Hrs in the chamber of GM (HR&A) in which DGM (Admn), AGM (Admn) were present along with the Representatives of BSNLEU & NFTE.

The following decisions were taken in the meeting :-

1. Earlier guidelines in respect of transfers and postings of non-executives in the SSA issued vide this office Lr.No.TT/STC/7-1/2016-18/87 Dated 16-03-2018 and 1-5-2018 shall hold good for the current financial year also.
2. Considering the recent guidelines issued by BSNL, Corporate Office, New Delhi for economy measures and rationalization of expenditure, it was agreed upon that all the transfers including tenure transfers/ deployment to rural / unpopular stations are to be done Without TA/TP.
3. Normally, no CSC should be closed by SSAs. In case SSA wants to close any CSC, it should be done with the prior approval of Circle Office. Posting of staff to CSCs should be done by the SSA Head considering the revenue and market potential.
4. In Telangana Telecom Circle, nearly 246 exchanges were closed. Staff working in these exchanges may be utilized for Sales and Marketing activities. Any surplus staff may be posted by calling options for bringing the staff who were posted under deployment.
