Reference:- Letter No. 250-2/2014-Estt.III dated 22.02.2019.

Sir.

In reference to aforesaid letter, I am directed to convey the approval for conduction of aforesaid LICE. The Model Exam Notification for LICE to the cadre of Telecom Technician is enclosed herewith and same have to be notified by all the circles accordingly.

- The examination shall follow the recruitment rule of Telecom Mechanics 2012 issued vide letter no. 250-3/2012-Pers.III dated 19.09.2012. The said LICE for Telecom Technician (erstwhile Telecom Mechanic) shall be conducted in accordance with the scheme and syllabus prescribed vide office letter no. 250-74/2001-pers.III (Pt.) dated 18.10.2011.
- 2. The total vacancies in the cadre of Telecom Technician as on 31.03.2019 may be calculated and then 50% of the vacancies may be earmarked for the LICE 2018, under intimation to cadre controlling authority i.e Establishment section, BSNL CO. The recruitment year for the LICE for Telecom Technician shall be 2018. The crucial date for reckoning the eligibility of candidate for appearing the said LICE shall be 1<sup>st</sup> July ,2018. It may be noted that the LICE of Telecom Technician may be held in those SSA where:
  - i. There is a clear vacancy and no qualified and trained official is waiting for his/her absorption in Telecom Technician cadre for want of vacancies.
  - ii. There is no court case pending in connection with the LICE for Telecom Technician.
  - iii. The vacancies of the non-recruiting Circles may also to be taken into account while notifying the vacancies of the particular SSA/Circle.

In case of any doubt for calculating vacancies position in a circle or SSA, cadre controlling authority i.e Establishment section may be consulted.

- 3. All circles will arrange demo class at their SSA level to familiarise the aspiring candidates for appearing in LICE. The demo class at SSA level may be imparted by Recruitment cell of each SSA.
- 4. LICE will be held in all Telecom circles in centralised manner on the fixed Date/Time strictly.
- 5. The concerned circle shall arrange /collect at least two sets of question papers for the said exam as per the scheme /syllabus from any other circle, in utmost secret and time bound- manner. The receipt question papers shall be opened by the nominated Exam Co-ordinator of the circle for final checking and compliance if any, confidentiality shall be maintained at all stages.
- 6. All the circles are requested to adhere the timeline provided without fail.
- 7. Any other factor/points etc. not mentioned herein that may be useful for conducting the written examination smoothly may be incorporated at circle level.

With the approval of the Competent Authority, it has been decided to hold a Limited Internal Competitive Examination (LICE) in offline mode for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on 08/09/2019 in order to fill up the vacancies for the vacancy upto 31.03.2019 as per the provision in the Recruitment Rule of Telecom Technician (Erstwhile Telecom Mechanic) circulated vide BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19.9.2012; the scheme & Syllabus circulated vide BSNL Corporate Office Letter No. 250-74/2001-Pers-III (part) dated 18<sup>th</sup> Oct 2011 shall be applicable for same (Annexure-A & B).

The recruitment year of the LICE for Telecom Technician shall be 2018; 01.07.2018 shall be the crucial date for reckoning the eligibility of candidate for appearing in the LICE, as conveyed by BSNL Corporate Office Letter No. 250-2/2014-Estt-III dated 22<sup>nd</sup> Feb 2019.

- 4. There will be negative marking and for each wrong answer 25% of the mark of that question shall be deducted.
- 5. Minimum qualifying marks prescribed is 30% in each part and 37% in aggregate in respect of 'OC/OBC' candidates and 20% in each part and 30% in aggregate in respect of 'SC/ST' candidates.

- 6. The eligibility for appearing in the above mentioned Limited internal Competitive Examination shall be as per existing Recruitment Rules issued by BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19<sup>th</sup> Sep 2012 (Annexure-A).
- 7. The LICE will be held in 28 BSNL Territorial Circles/Telecom Districts/NTR at their respective headquarters. The details of the Territorial Circles where the LICE will be conducted are given at **Annexure-C**.
- 8. The employees, who are eligible in accordance with the eligible conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit application offline to the **Controlling authority as nominated** by the respective Circles. Data is also required to be verified in SAP/ ERP.
- 9. Applications will be considered only in the stipulated period mentioned above i.e. from 15/07/2019 to 14/08/2019 (to be done at SSA/Circle). Candidates will have to provide valid details as per Annexure-D.
- 10. There shall be registration fee for aforesaid LICE of Rs. 500 for Gen/OBC candidate and Rs. 250 for SC/ST candidate.
- 11. Application forms (Annexure-D) complete in every respect must be submitted on or before **14/08/2019**; after this date no application will be accepted.
- 12. The applicants would be admitted to the examination on the basis of the information furnished by them in their registration form. All the Candidates are, therefore, advised to ensure the fulfilment of all eligibility conditions before applying. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfil any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies in the LICE and no correspondence in this regard would be entertained. Issuance of a Admit card for the examination will NOT confer any right for promotion or otherwise. Promotion will be solely provisional subject to the fulfilment of all eligibility conditions/vacancy/merit.
- 13. No electronic gadget or mobile phone etc. will be permitted to be taken inside the examination premises by the candidates.

#### Recruitment Rules of Telecom Mechanic in BSNL

New Delhi, the 19th September 2012

#### 1. Short Title and commencement:

- (i) With the approval of BSNL Board and in supercession of the Recruitment Rules of Telecom Mechanic-2002, the following rules regulating the method of recruitment to the post of Telecom Mechanic in BSNL are hereby made, namely
- (ii) These rules may be called the Telecom Mechanic (Recruitment) Rules, 2012.
- (iii) These rules shall come into force from the date of their publication and shall also be applicable to all Limited Departmental Competitive Examinations to be notified in future after publication of these Recruitment Rules by the Company.
- 2. <u>Definition:</u> In these Rules unless the context otherwise requires,
  - (i) <u>Company:</u> Means the Bharat Sanchar Nigam Limited (A Government of India Enterprise) having its Registered Office at Bharat Sanchar Bhawan, Janpath, New Delhi.
  - (ii) <u>Board:</u> Means the Board of Directors of the Company and includes in relation to the exercise of powers any Committee of the Board/Management or any other Officer of the Undertaking to whom the Board delegates any of its power.
- 3. Application: These Rules shall apply to the posts as specified in Column (1) of the Schedule annexed to these Rules.

- Number of posts, Classification and scale of pay— The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed.
- Method of Recruitment, age limit, qualifications etc.——
  The method of recruitment, age limit, qualification and other matters relating to the said post shall be specified in Column 5 to 13 of the Schedule annexed.

#### **Disqualification**----No Person:-

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who having a spouse living, has entered into or contracted marriage with any person,

Shall be eligible for appointment to the said posts;

- Pre-appointment training:

  The selected candidates before appointment shall have to successfully undergo the prescribed training for such period as may be specified from time to time by the BSNL. The officials who fail to complete the training successfully will not be promoted/appointed as Telecom Mechanic.
- 8. <u>Liability to serve under the P&T (Territorial Army)</u>
  Signal Units:----All candidates shall, if so required, be liable to serve in the Posts and Telegraphs (territorial Army) Signal Units as provided in the Territorial Army Act 1948 (56 of 1948) and the rules made there under.
- 9. Saving:----Nothing in these rules shall affect reservations, relaxation of age limited and other concession required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-Serviceman and other special category of persons in accordance with the orders issued by the Central Government from time to time in this regard.
