I am directed to refer to the above cited subject and to inform that still large numbers of pension cases are pending where PPO has not been generated. A status report as on 09.06.2020 as received from DOT is enclosed herewith for reference. DOT as well as BSNL Management has viewed it very seriously.

- 2. It has further been informed by DoT that some circles have large number of pending pension cases which have not been received by them so far e.g. (i) Maharashtra 4529 cases, (ii) Telangana 600 cases, (iii) Tamil Nadu 350 cases, (iv) Odisha 150 cases, (v) West Bengal 150 cases, (vi) NE-II 100+ cases, (vii) MP 70 cases, (viii) Bihar 48 cases etc.
- 3. It is, therefore, requested that the sending of pending pension cases to respective CCAs offices may be expedited and the cases already sent may be pursued for early generation of PPOs.
