Subject: Immediate sending of pending pension cases to CCAs for generation of PPOs in respect of the employees retired voluntarily under the BSNL VRS-2019.

Sir,

I am directed to refer to this office letter of even no. dated 23.06.2020 on the above cited subject and to forward herewith the latest status (as on 19.06.2020) of the pension cases sent to CCA offices for settlement of pension in respect of retirees under BSNL VRS- 2019. It is observed that even after regular reminders from this office, the sending of pension cases to CCAs has not improved in some circles.

2. Further, it has been noticed that the pension papers of the VC withheld cases are not being sent to the CCA offices. In this regard, it is informed that such retirees will be considered for payment of provision pension by the respective CCAs. Therefore, sending of such pension cases may be immediately undertaken and their early settlement may be ensured by close coordination with CCA offices.

3. Another issue which has come to the knowledge of this office that in respect of VC withheld cases payment of Leave encashment has not been initiated by the circles. Clear instructions have been issued by this office as per letter No. BSNLCO-EB-I/11(20)/ 5/2020-ESTAB dated 06.05.2020 (available on BSNL Intranet). In this regard, it is again requested that the details of EL encashment finalized in such cases may be immediately updated in the ERP / SAP portal.

This may be treated as most urgent.
