He may further be requested to complile a list of module wise SPOCs at circle level and submit to this office on mail ID basiscore@bsnl.co.in by 17.10.2020.

It may be noted that aforesaid activities for consolidation of BAs in respect of HP and J&K circles have already been completed in ERP system. Hence these circles may go ahead with administrative restructuring as per orders of BSNL CO.
