In respect of employees, whose salary is not being prepared due to administrative reasons e.g. transfer, deputation outside BSNL or EXOL etc, it is the responsibility of the concerned employee / member of GTI to deposit the premium with the concerned DDO in their last unit of posting in BSNL so that the DDOs are able to execute the process for deduction of premium. The concerned DDOs may contact ERP HCM Team at ALTTC Ghaziabad in case of any query regarding processing of such cases. It is reiterated that only those cases will be forwarded to LIC of India for GTI coverage whose premium is deducted in the month of FEB-2021.
