It was largely the dedication of BSNL employees that enabled us to provide uninterrupted service during these testing times. However, as a result of all this many BSNL employees have already been infected with COVID-19 while doing their duty which has created fear and panic among the BSNL employees. Even though enough precautions are being taken in the offices/ sections where public is visiting for bill payment and other service related issues and where employees are working in the field for maintenance of network, there are more chances of infection to the front line staff of BSNL.

We have requested the Chief Secretary, Govt. of Telangana to take cognizance of contribution of BSNL employees in the fight against COVID-19 and take suitable measures to include the entire BSNL workforce in the priority population for COVID-19 vaccination vide letter under reference 2. 
