CIRCULAR No.02/2021-PHA

Subject: Policy for provision of FTTH Service Connections in BSNL Office-Reg.


Following policy has been framed with the approval of competent authority for provision of FTTH Service Connection in the offices of BSNL as per details given below:

- 1) In the Offices where LAN connectivity for internet and intranet is already extended to the officers/users, FTTH connectivity should not be extended.
- 2) In case of MTNL area, where there is no LAN connectivity , FTTH limited to Rs 795 with Wi-Fi modem may be provided to GM and above level officers on need basis with the approval of DIR(HR).
- 3) In case of OLTs installed by BSNL and where there is no revenue sharing with TIPs, the following plan may be provided in BSNL offices :
 - a) For GM and above level officers: 799 FTTH Fiber Plan having 100 Mbps speed till 3300 GB thereafter 2Mbps speed may be provided.
 - b) For AGM/DGM level officers : 599 FTTH Fiber Plan having 60 Mbps speed till 3300 GB thereafter 2Mbps speed on need basis may be provided with the approval of CGM.
 - c) The cost of modem/fiber etc. for last mile connectivity shall be borne by the concerned Circle.
 - d) OTT(Over the Top) subscription shall not be provided on the said plans.
- 4) The provision of FTTH shall be subjected to its feasibility.
- 5) Security guidelines issued by Corporate office should be implemented, while giving internet connectivity through FTTH for the office working.


