Sub:- BSNL COVID Fund (BCF) Policy – Regarding.

Ref.: This office letter of even number dated 20.05.2021 & dated 17.06.2021.

BSNL CO vide letter dated 20.05.2021 has circulated Policy and instructions of BSNL Covid Fund policy as per which the family of each deceased employee who died of COVID will be provided a financial support of Rs 10 lakh from the BCF.

As per the provision of the policy, the death cases due to COVID may be submitted within 30 days of issue of policy (for the death occurring prior to issue of policy i.e. 20.05.21) and within 30 days of the death of the official thereafter. Further, as per Para 2 - Scope & Duration of the policy "*the fund will be in operation till 31.03.2022 or as recommended by BCF Committee and approved by BSNL Management (CMD, BSNL). The period of operation of BCF/ contribution can be increased/ reduced suitably depending on the Covid Pandemic situation and the mortality rate based on the recommendation of the BCF Committee*".

As on 31.03.2022, a total of 231 cases of deceased BSNL official due to COVID19 has been forwarded by the various Circles to BSNL Corporate Office. A copy of the Circle wise list is attached herewith.

It is, therefore, requested to check the cases of your Circle in the attached list and if there is any left out eligible death case due to COVID19 occurred on or before 31.03.2022, the same may be forwarded to this office **by 30.04.2022** as per instructions contained in Annexure-2 of letter dated 20.05.2021.
