Subject: Inter circle transfers of JTOs(T)/ JEs(T) under Rule 8 of BSNL Transfer Policy.

Kind attention is invited to this office letter(s) dated 23.02.2022, 27.04.2022, 06.06.2022, 16.06.2022 & 17.06.2022 under reference on the subject cited above, vide which all the recruiting circles in BSNL have been broadly categorized as Surplus, Deficit and Just Sufficient Circles for the purpose of transfers in r/o JTOs(T) & JEs(T) under Rule 8 of BSNL Transfer policy. To ensure even distribution of JTOs/JEs vis a vis Sanctioned Strength, it was requested that all the pending Rule 8 transfers (from surplus to deficit circles) in r/o JTOs(T)/JEs(T) may be processed in accordance with the extant guidelines.

In this regard, certain circles have raised doubts regarding the processing of Rule 8 transfers from Surplus to deficit circles, Just sufficient circles to deficit circles, deficit to deficit circles etc. Accordingly, in continuation to the above, the following is hereby clarified:


1. Rule 8 Transfers from Surplus to Deficit circles are to be done irrespective of Rule 8 waiting list number as illustrated vide letter dated 16.06.2022.

2. Rule 8 Transfers from Just Sufficient/Deficit circles to Deficit circles may be decided by CGMs of Just Sufficient/Deficit circles based on the vacancy position of JTOs/JEs vis a vis respective Sanctioned strengths, with the condition that working strength in any circle post transfer does not exceed its Sanctioned strength.

3. The Rule 8 Transfer to Surplus circle shall not be allowed under any circumstances. Therefore, while considering rule 8 transfers, requests in the waiting list for surplus circles may be ignored.

The circles are requested to process the pending Rule 8 Transfer cases in accordance with the above clarification.
