With reference to above cited letters, I wish to submit that I have requested your kindness in RJCM held on 06-06-2023, that the guidelines issued by our circle office in respect of transfers of non-executives are to be implemented without any deviation. You are kind enough assured us that the guidelines issued in 2018 will be implemented in BA's/OA's.

But, the BA heads of Sangareddy and Warangal are not honouring them and given pick and choose transfers. I have brought the same to your kind notice vide our letters (1) NFTETS/Transfers/14/2023, dt-12.06-2023. (2) NFTETS/Staff issues of Mahaboob Nagar/15/2023, dt-12-06-2023. I have brought the facts to the notice of Sr. GM(HR) and DGM(A) twice and thrice. We feel that the management is not serious with non-executive issues. I am very sorry for it.

Once again I request your kind honour to intervene in the issues and resolve them amicably by honouring the guidelines issued by our circle office in 2018. (2) Request to cancel the irregular transfer orders given to Shri C. Venkatesh ATT in Sangareddy BA and Shri G. Venkateshwar Reddy, T.T in Warangal BA against to transfer policy. (3) Request to consider the long pending transfers of ATT/TT/JES in the Circle.

If the issues are not going to be resolved in 14 days time, there is no alternative for us except to go in trade union action after 14 days under section 22 of industrial dispute act 1947. This is for your kind information and action please.
