Kindly refer to this office letter No. 6-24/2023-TA-I/GPF Interest/663 dated 26-05-2023 and letter No. 6-24/2023-TA-I/GPF Interest/983 dated 12-07-2023 on the subject related to the payment of Interest on delayed payment of GPF Final Payment.

It has been observed that in the majority of cases, delays have occurred at BSNL's end due to late processing of documents and their submission to Pr. CCA/CCA offices for final settlement. Such delay not only causes hardship to the employee but also puts a financial burden on account of interest payments. In cases of such delay, proper investigation is to be carried out and responsibility is to be fixed against the erring employees by BSNL. The issue related to the delayed payment of GPF has been repeatedly raised to BSNL by the DOT HQ. In the past, D.O. letter was sent to BSNL for a detailed examination of the delay and fixing the responsibility.

Secretary (T) has taken a very serious view on the delayed payment of GPF and instructed to carry out a thorough investigation and fix responsibility against the concerned officials. A list of a few such cases is attached at Annexure - 1. The competent authority has desired that necessary action on the ibid subject matter please be taken and a detailed action-taken report may accordingly be submitted within 15 days without fail.
