Sub:- Notification to observe Nationwide “Call attention day” on the call of NFTE (BSNL) to settle legitimate demands of employees.

Respected Sir,

We wish to bring the following to your kind notice for favourable decision and settlement of long pending grievances of the non-executive employee.

A virtual meeting of National secretariate of NFTE (BSNL) held on 23.01.2024 and discussed the burning issues of non-executive staff in BSNL. After discussion in length the meeting came in conclusion that all the efforts made by the union has gone in vane and the burning issues of employees are still untouched by the management and administrative ministry and the meeting decided unanimously to organize “call attention week” from 13th Feb. 2024 to 17 Feb. 2024 for settlement of the following burning issues of the employees.

1. Implementation of 3rd wage revision by providing relaxation in affordability ^{clause} ~~clause~~ in DPE guideline issued for the wage revision.
2. Framing new time bound promotion policy at par with the promotion policy of the executive employees of BSNL.

3. Revise sanctioned strength in r/o ATT, TT, JE, JTO and JAO to end the surplus condition in several circles, in each cadre which causing nil vacancies in LICEs notified for the promotional cadre in about half of the circles.


Further the National secretariate decided to organize "Call attention week" from 13th to 17th Feb. 2024 to draw the attention of BSNL top management and to the DOT Authorities to apply favourable consideration to settle the issues without further delay.

The program will be as follows :-

1. Lunch hour demonstration from 13th to 15th Feb. 2024 to high light the demands. On 15 Feb. 2024. Submission of memorandum at all level viz circle/BA/OA address to the CMD BSNL and the Secretary DOT through the concern unit head.
2. Day Long Dharna and lunch hour demonstration on 16.02.2024—A mass Dharna will be organized on 16.02.2024 to high light the demands and to draw the attention of authorities.
3. Post Card Campaign— All the individual member will write and send a post card to Hon Prime Minster of India for his kind intervention to relax the affordability condition for implementation of the 3rd wage revision for BSNL employees.
