In the cases where the schools are awarding grades instead of marks, a certificate issued from the Principal of the school concerned showing the overall grading/equivalent to % of marks obtained in the class by the ward of employees is required to be submitted alongwith the form.

Employees drawing basic pay upto Rs.17,600/-p.m. (Pre-revised) and Rs.38,630/- p.m. (Revised) in IDA scale are eligible to apply for the book award subject to a maximum of two children.
